This same advanced technology has been in place for the mail service operations in the Centennial, Colorado headquarters and has improved capacity while delivering the highest levels of patient safety in the industry.

"We are opening this new facility to answer the increased demand for WellDyneRx' prescription drug services across the United States," says Susan Cain, Chief Operating Officer. "We strategically chose Lakeland, Florida to geographically balance our operations while providing us with a secure back up facility which enables us to better serve our growing customer base.
